



Approved Fee Structure by School Level Fee Regulatory Committee (SLFRC)

In compliance with the provisions of the School Level Fee Regulatory committee (SLFRC) Order dated 24.12.2025, Fee Structure of the school has been duly approved in accordance with the provisions of the Delhi School Education Act & Rules, 1973 and the guidelines issued by the Directorate of Education (DoE), Government of NCT of Delhi, regarding regulation of fee by the School Level Fee Regulatory Committee (SLFRC).

The School Management submitted a detailed and reasoned proposal before the School Level Fee Regulatory Committee for consideration of revision in the existing fee structure. The proposal was supported with:

- * Audited Financial Statements
- * Income & Expenditure details
- * Budget projections for the forthcoming academic sessions
- * Justification note for the proposed revision

The meeting of the School Level Fee Regulatory Committee was duly convened on **Friday, 13 February 2026**, with prior notice to all members as per prescribed norms. The meeting was attended by:

- * Chairperson
- * Principal/ Secretary
- * Elected Parent Representatives
- * Teacher Representatives
- * Observers from Directorate of Education (DoE)- DE' Nominee(s)

The quorum was complete as mandated under SLFRC guidelines.

After detailed deliberations, transparent discussions, examination of financial documents and addressing queries raised by parent and teacher representatives, the Committee, through consensus of all members present, approved the proposed revision.

Accordingly, the revised Fee Structure stands approved for implementation for the next three academic sessions, namely:

- * Academic Year 2026–27
- * Academic Year 2027–28
- * Academic Year 2028–29


The approved revision reflects a moderate annual impact of 10% in the 1st Year (2026-27) and 7% each in 2nd Year (2027-28) and 3rd Year (2028-29). The Committee noted that:

- * The increase is reasonable. It does not impose an excessive financial burden on parents.
- * It enables the school to effectively manage operational costs, statutory salary obligations, quality enhancement, and infrastructural upkeep.
- * It ensures continuity of academic excellence and student support services.

The detailed approved fee structure is appended below for reference and has also been uploaded on the school website in the interest of transparency.

The school reaffirms its commitment to full compliance with Government norms and maintaining transparency in all matters relating to fee regulation.


